The experience of Good e-Guidance Stories in the European landscape of Vocational Training and Active Labour market policies

GeGS – Good e-Guidance Stories is a project funded by the European Commission in the framework of the **Erasmus+ Programme**, under the action of policy experimentation. Its strategic objective is the modernisation of the role of guidance, support and preparation to work in the context of vocational training and active employment policies.

While **GeGS** has been operationally up and running for a year and a half, the **Conference Choosing Today and Tomorrow** aims to take stock of the main issues informing our project and analysed during the experimentation phase. In a national and international fast-paced scenario, and in some ways dramatic evolution, the conference emphasises the structural challenges that Italy in general, and the Sardinian territory in particular are facing: the need for a structural reform of the entire training system, in light of the ambitious objectives of the PNRR and the **GOL programmes – Guaranteed Employability and Employment** - and all the steps they entail.
